Assignment Title: 1200647 - Development of Indonesia Extractive Industries Data Portal

ASSIGNMENT DESCRIPTION

The World Bank is supporting the Government of Indonesia to implement the Extractive Industries Transparency Initiative (EITI), a global standard that promotes revenue

transparency and accountability in the extractive sector. Indonesia formally assumed EITI candidacy in October 2010, and was found to be compliant with EITI Rules in October 2014.

The objective of the assignment is to establish a Portal for EITI Indonesia to house EITI reports, along with the associated datasets, information and an interface to promote analysis of this data by users. The Portal will be a website that serves as one-stop platform that brings together data across the extractive industries value chain in Indonesia.

The Portal will not only serve as platform for users to find data, but also to present data in user-centered, engaging, interactive, and visually appealing way. Users should be able to interact with the data presented, with the ultimate aim of gaining a better understanding of the extractives sector generally, the economic significance of the sector, and how citizens can contribute to improve the process.

The Portal will initially house the reports and datasets from 2009-2013 that have been collected, and will become the platform for housing future EITI products. The Portal and datasets will be managed by the EITI Indonesia Secretariat, housed in the Coordinating Ministry for Economic Affairs, and will build on its existing website: <http://eiti.ekon.go.id>. In the future, the Portal is intended to be used also as a platform for online reporting to collect data from companies and relevant government entities more efficiently.

To support this objective, the World Bank intends to contract a firm to design and implement alpha and beta versions of the Portal during a 6-month period between October 2015 and March 2016. The selected consultant shall: a. build a website (the Portal) to enable easy publication and consumption of the EITI Indonesia reports and datasets; b. transform datasets from all EITI reports (2009-2013) into more reusable format (i.e. open data format); c. design a database containing all data collected through the EITI process; d. provide documentation of Portal development; e. provide training for Portal operators and users. In designing the Portal, the firm will consult closely the MSG and the stakeholders from government, industry and civil society, who are prospective users of the Portal.

The firm will be expected to provide a team based in Jakarta for the duration of the contract, and must have demonstrable track record in similar assignments, developing complex, interactive and visually appealing websites under a tight deadline. Experience in working with government and civil society is also desirable.
